#### Deffenbaugh Trash Service Changing for NHHA members Effective January 1, 2007

Effective January 1, 2007, Deffenbaugh Industries will only offer once a week trash pickup for Nall Hills members. They will continue the Monday/Tuesday weekly pickup only. Thursday/Friday pickup will be discontinued completely.

Citing increased fuel and operating costs over the years, Deffenbaugh is discontinuing all twice a week pickup schedules in their entire service area. We are the last remaining customer affected by this change. This change affects the rates Deffenbaugh charges Nall Hills and is reflected in the 2007 proposed budget and the annual dues paid by each homeowner.

### Annual "Big Item" Trash Pick UP

**Weekly Trash Pick Up:** January 1<sup>st</sup>, 2007 the one pick up per week will be Monday or Tuesday at the curb. <u>Trash may be set out up to, but no more than, 24 hours ahead of time.</u> For yard trash the maximum of 10 bags per pickup, cut tree branches into lengths of four feet, tied in bundles of no more than 18 inches in diameter, and maximum 65 lb weight limit. Building materials are not allowed. Special pick-ups, call 631-3300.

#### About the Nall Hills Homes Association...

The Nall Hills Homes Association was formed in 1956 when the Nall Hills neighborhood first began construction.

It has grown from 64 homes initially to the current 1264 homes.

This makes Nall Hills the second largest homes association in Overland Park, bordered on the north by 95th Street, on the south by Indian Creek, on the east by Nall, and on the west by Glenwood.

The Board of Directors meets nine months out of the year at the Community Area Credit Union to plan activities and to address issues that are brought up by residents.

#### Treasurer's Report

Treasurer Mark Able recommends the annual assessment for the year 2007 be set at \$103 per household (a \$19 decrease from 2006). A reduction in the trash pick-up frequency by Deffenbaugh Trash Services (to once a week) with a corresponding decrease in cost is the main reason for this proposed decrease in 2007. All other expenses are expected to remain at current levels with minor inflationary adjustments. Mr. Able will entertain questions/concerns regarding the proposed assessment rate and budget line items from the attending homeowners at the annual meeting.
