About the Nall Hills Homes Association...

The Nall Hills Homes Association was formed in 1956 when the Nall Hills neighborhood first began construction.

It has grown from 64 homes initially to the current 1264 homes.

Nall Hills is considered to be the second largest homes association in Overland Park, bordered on the north by 95th Street, on the south by Indian Creek, on the east by Nall, and on the west by Glenwood.

The NHHA Board of Directors meets nine months out of the year at the Community Area Credit Union, the first Wednesday of each month at 7pm, to review general operations, schedule activities, and to address other neighborhood issues.

Treasurer's Report

Treasurer Mark Able recommends the annual assessment for the year 2008 be set at **\$106** per household (a \$3 increase from 2007). An increase in the trash pick-up charges by Deffenbaugh Trash Services is the main reason for this proposed increase in 2008. All other expenses are expected to remain at current levels with minor inflationary adjustments. Mr. Able will entertain questions/concerns regarding the proposed assessment rate and budget line items from the attending homeowners at the annual meeting.
