*** News Flash - New Trash Service Provider for 2009 ***

As you know by now, there have been some major changes taking place at Deffenbaugh Industries lately. Our association's contract with Deffenbaugh expires on 12/31/08 and we have put our contract out for bid. We have received bids from 4 providers, including Deffenbaugh. The one common theme we are seeing from each one is the large increase in pricing across the board and the uncertainty of yard waste collection options.

To that end, we will be changing trash providers effective 1/1/2009. L&K Services will be our new provider for 2009. Their pricing and service offerings closely match our current requirements and expectations for all of our residents. New limits for household and yard waste will be 8 bags each. Right now, it looks like pickup days will be Tuesday and Wednesday in 2009, but the exact days and route plans have not been finalized. (please see pg 2 for more info)

New Trash Service Provider for 2009 (continued from pg1)

Currently, we are not sure how this will impact recycling services provided by Deffenbaugh and subscribed individually by homeowners who want to participate. The City of Overland Park is

considering some changes with the recycling program, but has not made any final decisions. It is anticipated that with either Deffenbaugh or L&K Services, your semi-annual

charge for recycling will increase. Currently, your recycling fees are not included in your annual homes association dues. We will let you know of any changes as soon as we can.

About the Nall Hills Homes Association...

The Nall Hills Homes Association was formed in 1956 when the Nall Hills neighborhood first began construction.

It has grown from 64 homes initially to the current 1264 homes.

Nall Hills is considered to be the second largest homes association in Overland Park, bordered on the north by 95th Street, on the south by Indian Creek, on the east by Nall, and on the west by Glenwood. The NHHA Board of Directors meets nine months out of the year at the Community Area Credit Union, the first Monday of each month at 7pm, to review general operations, schedule activities, and to address other neighborhood issues.

Treasurer's Report

Treasurer Mark Able recommends the annual assessment for the year 2009 be set at \$146 per household (a \$40 increase from 2008). The increase in the trash pick-up charge is the main reason for this increase in 2009 ⁽¹⁾. All other expenses are expected to remain at current levels with minor inflationary adjustments. Mr. Able will entertain questions/concerns regarding the proposed assessment rate and budget line items from the attending homeowners at the annual meeting.

(1) – Nall Hills negotiated rates represent a minimum \$78 savings per year over standard rates.
