### Trash Collection Survey Results

In anticipation of the upcoming expiration of the HOA's current trash service contract with L&K at 12/31/16, the board initiated a four question survey to the entire membership, in October 2014 (via the fall newsletter).

Members were able to respond via the NHHA website or directly to our office (newsletter insert). The survey closed on Aug 1, 2015. The Board thanks all who took the time to respond (we had 263 respondents). Here are the results of the survey, which will be referenced in the upcoming contract negotiations: 1) Are you satisfied with the current collection arrangements with L&K Services (including the yard waste collection for 41 weeks out of 52 total weeks)? YES 87% / NO 13%

2) Knowing that the annual dues could increase proportionately, would you be in favor of extending yard waste collection to 43 weeks out of 52 weeks? YES 24% / NO 76%

3) Knowing that the annual dues could increase proportionately, would you be in favor of extending yard waste collection to 50 weeks out of 52 weeks? YES 8% / NO 92%

4) With the possibility that your annual dues could decrease slightly but with the understanding that you would be required to have larger garbage cans for automated pickup of household waste and recycling, would you be in favor of automation? This change would introduce trucks with automated pickup arms (excluding yard waste pickup). (Note that you would be required to keep these cans out of sight, either in your garage or enclosed, as per the City of Overland Park.).

# Letter to Nall Hills from Squad House #47

Below is a letter from Chief Bryan Dehner regarding their new home here in Nall Hills at Squad House #47.

Almost one year into operation, the folks at OPFD Squad House #47 will tell you they're enjoying their new home and their new neighbors.

While some neighbors were understandably nervous about having emergency responders move in next door, OPFD's EMS Lieutenant, Alex Sweat says crews have been welcomed into Nall Hills with warmth and generosity. Some neighbors have brought kids over to see the Squad and a few have even dropped off homemade baked goods for the crews. Other than a small plaque by the door, Squad House #47 looks like any other home in Nall Hills. Since beginning service at the end of 2014, Squad #47 has responded to more than 1,500 calls for service. They've been averaging about 175 calls per month. In fact, they've responded to more than 200 calls right here, in Nall Hills!

The Squad House model is proving to be a right sized, cost effective solution. So much so that Overland Park Fire is looking to implement this strategy in other parts of the city where communities might benefit similarly.

EMS Chief, Brad Cusick says crews recently received the ultimate sign that they've been accepted into the neighborhood. One adjacent neighbor has designated the front yard of Squad House #47 as their "family meeting place," telling their children to gather there should they have a fire in their home.

From all of us at the Overland Park Fire Department, thank you for welcoming us into your neighborhood. It is an honor and a privilege to live in and serve the people of Nall Hills.

### New Ownership at L & K Services

Earlier this year, Waste Management (WM) announced the acquisition of Deffenbaugh Industries and L&K Services. Based in Houston, Texas, they are the leading provider of comprehensive waste management services in North America, providing collection, transfer, recycling and resource recovery, and disposal services for residential, commercial, industrial, and municipal customers. The NHHA board has been in constant communication regarding the acquisition

and transition plans. WM is planning to keep these two entities operating separately, as they recognize the existing brand recognition in the Kansas City area. Additionally, they made a significant investment in new emission efficient equipment. The current Nall Hills contract will not be impacted with this ownership change. However, our contract does expire in Dec. 2016, so we anticipate there could be some changes. As you reference the survey results in this

newsletter, the board will continue working to meet our needs based on what is available in the marketplace. Some of you have also noticed Deffenbaugh trucks in our neighborhood. In maintaining some of their trucks, L&K borrowed a few Deffenbaugh branded trucks. The employees are still L&K employees, so you should expect the same great service. With the ownership change, this could become a more frequent occurrence over time.

# Yard Waste, Recycling, and Other Reminders

Please review the information below as a reminder of our neighborhood waste disposal services offered by L&K Trash Services.

Household waste: Limited to 3 bags or 3 cans or 1-95 gallon container. If you have more than the weekly limit, ask neighbors to help share and then be sure to return the favor, if asked. Or, if you have a larger load and can't wait, extra stickers can be purchased from L&K and placed on each item over the limit.

Yard waste: Limited to 6 biodegradable bags or bundles weekly (except as noted in the winter pickup schedule found in this newsletter). It is important to remember, plastic bags or regular trash containers CAN-NOT be used for yard waste.

L&K increases the yard waste limit to 10 bio-degradable bags weekly, in November and December.

Bulky Item Pickup: This special service is ONLY available the first week of each month. Please do not put your item out any other week 'hoping' someone will take it. This detracts from our neighborhood's beauty.

Recycling: Included in the services for our neighborhood. Anyone can participate in this unlimited service. You can use the bins provided by L&K or any container you have as long as it is clearly marked as "RECYCLE." You are encouraged to recycle!

# Treasurer's Report - Proposed 2016 Budget

Treasurer Mark Able recommends the annual assessment for the year 2016 be set at \$201 per household (a \$3 increase from 2015). The increase in trash service expense is the main reason for the dues increase for 2016. All other expenses are expected to remain at current levels or rise moderately. Mr. Able will address questions and concerns regarding the proposed assessment rate and budget line items at the Annual Meeting.

A Certified Public accounting firm audits all accounts at the end of each fiscal year. Copies of the audit reports are available at the meeting and are open to public inspection, upon written request to the board of directors. Details regarding current income and expenses and the basis for the recommended budget will be discussed at the annual meeting.

# A Nall Hills Historical Perspective: Billy Tyson

Billy Tyson was born in Bellevue, Texas in 1925, a small town on Hwy 287 between Wichita Falls and Fort Worth. A WWII veteran, Billy and his wife Charlene first moved the family to Prairie Village in 1963, then to Nall Hills in 1964.

The move was suggested to Billy by his employer who lived in Nall Hills and described the neighborhood as a '...choice area to raise a family". He purchased the home for \$22,000 after securing a loan from the Capitol Federal Savings & Loan on 95th and Nall. As original owners of their house on Woodson, Billy's three kids Sharon, Valerie, and James, attended John Diemer Elementary, Indian Woods Middle School, and Shawnee Mission South HS. They all still live in the area, with James also currently residing in Nall Hills.

He recalls the corner lots were mostly undeveloped, and were great 'open spots' for the neighborhood kids to play. The grocery store at that time was a Milgram's, located at the southeast corner of 95th/Nall, where the CVS currently is. Billy is enjoys his retirement, going for walks, and is blessed with 8 grandchildren, and 7 great grandchildren. He has many fond memories of living and raising a family in Nall Hills. Looking back over the past 50 years, he describes the neighborhood as a "good, friendly place to raise a family" and is glad to see a resurgence of younger generations with children moving into the area.

Many thanks to Billy for sharing his memories with us and being a good neighbor in Nall Hills.

## Winter Schedule for Yard Waste Pick-up

### Yard Waste pickup is limited in the Winter months.

Please review the schedule noted below or you can find the Yard Waste Collection Calendar on L&K's website under the Residential, Yard Waste Removal tabs. In general yard waste will be picked up as follows: **December 2015:** First two weeks only

**January 2016:** Week of Jan. 11th only

**February 2016:** Week of Feb 8<sup>th</sup> only

**March 2016:** Week of March <sup>7h</sup> and every week after starting the week of March 21st

If you forget and put your yard waste out and it does not get picked up, please retrieve your bags/bundles from the curb and try again, using the above schedule.

Help keep your Nall Hills neighborhood free from unsightly trash left at the curb. NOTE: Please let us know of any quality workmanship!

We continually need new recommendations, as the list gets quickly outdated.

### **Barking Dog Complaints:**

We continue to receive an unusual number of phone calls regarding an excessive amount of barking dogs in the neighborhood. As a common courtesy to your neighbors, please take responsibility for your animals and help control any excessive barking. If you are at work most of the day, don't leave them out all day-you may not know they bark all day. The City of OP has a noise ordinance you may want to research to avoid any fines that could be assessed.

### Our Homes, Our Neighborhood - Be a Good Neighbor

### Trees:

Many of the trees in Nall Hills are getting older, which results in more dead branches. These present a risk to homes, cars and people. Homeowners should assess this risk and have a licensed, insured service remove dead branches from their trees before they break off.

Any fallen limbs should be bundled in 4 foot sections and put out with the trash. Larger logs may be stacked for firewood or must be removed from the property.

### Trailers, recreational vehicles and boats:

The city of Overland Park has codes and restrictions regarding the parking of trailers, recreational vehicles and boats. Some of the Nall Hills residents use trailers for business and are not aware of the city codes regarding parking of these vehicles.

### Trash cans, lawn mowers and ladders:

Nall Hills Homes Association follows the codes established by the City of Overland Park regarding the exterior storage of items. Trash cans and lawn equipment must be stored "within a fully enclosed structure or screened from view from any street or neighboring property."

### Monthly bulky item pickup:

Bulky items: The first week of every month, each homeowner is allowed ONE bulky item to be picked up on their trash day. Restrictions - no appliances and item must not be longer than 5 feet in length.
