2025 Budget Proposal VOTE REQUIRED

Treasurer Mark Able recommends the annual assessment for the year 2025 be set at \$256 per household (an \$8 increase from 2024). The increase in trash service expense is the main reason for the dues increase. All other expenses are expected to remain at current levels or increase moderately. Mr. Able will address questions and concerns regarding the proposed assessment rate and budget line items at the annual meeting.
