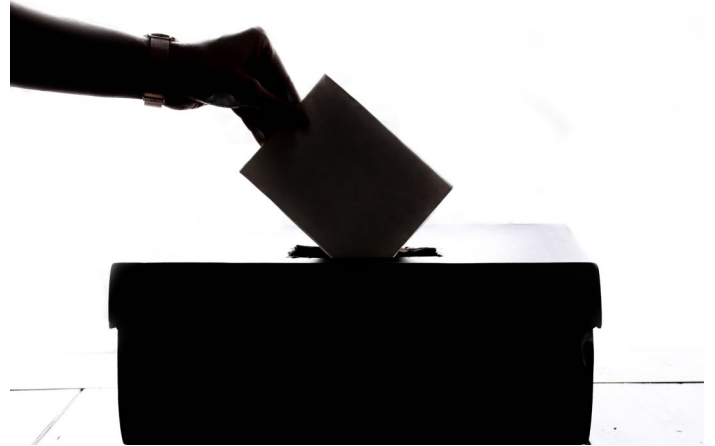


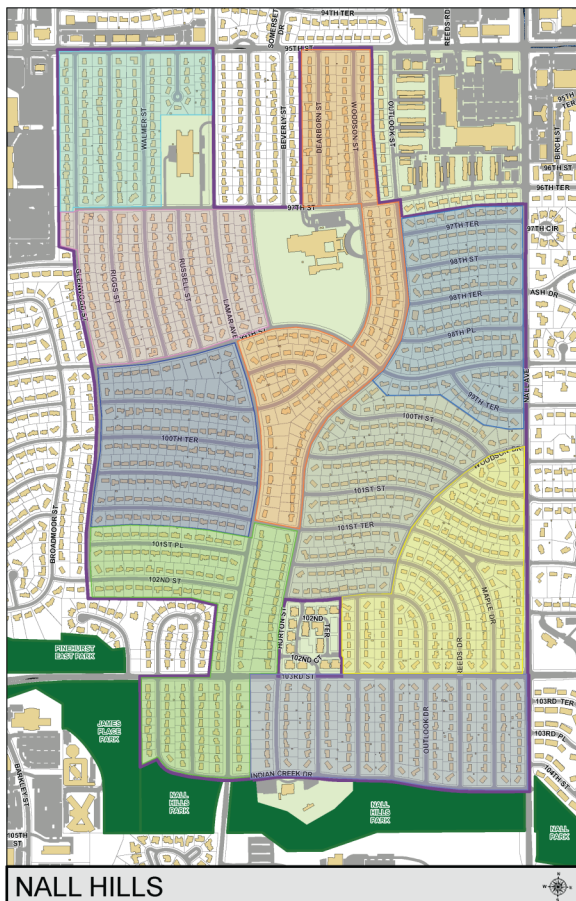
You are more than just another neighbor . . .

Per the bylaws of the Nall Hills
Homes Association (NHHA):

- All directors are members of the NHHA
- Four members are elected each year to 2-year terms by a majority of voting members at the annual meeting of the NHHA
